# Schedule B (Standard Terms and Conditions)

### 1. INTRODUCTION

- 1.1. This Event Registration Standard Terms and Conditions ("Standard T&C") shall govern the Event Registration that is organized by the Company as named in Schedule A. The Standard T&C and shall be in addition to the terms as set out in Schedule A (Schedule A and the Standard T&C shall collectively be referred to as "Terms and Conditions").
- 1.2. The Event Registration will be held during the Registration Period as set out in Schedule A. The Company reserves the right to vary, postpone or re-schedule the dates of the Event Registration or extend the Event Registration Period at its sole discretion.
- 1.3. The brief mechanism of the Event Registration is set out in Schedule A. The Registrants must adhere to the mechanism of the Event Registration as may be briefed and communicated to the Registrants by the Company from time to time during the Event Registration Period.
- 1.4. The Event Registration will be organized by the Company in the Event Registration Language as set out in Schedule A.
- 1.5. The Event Registration Procedure is as set out in Schedule A.
- 1.6. The Company reserves the right to at any time, change, amend, delete or add to the Terms and Conditions and other rules and regulations including the mechanism of the Event Registration at its absolute discretion.
- 1.7. The Company may terminate or suspend the Event Registration at any time at its absolute discretion in which case, the Company may elect not to giveaway any tickets. Such termination or suspension will not give rise to any claim by the Registrants. If the Event Registration is resumed by the Company, the Registrants shall abide by the Company's decision regarding resumption of the Event Registration and giveaway or disposition of the tickets.

#### 2. EVENT REGISTRATION PROCEDURE

2.1. The Event Registration entry must be complete, accurate and sent to the Company vide the Mode and to the Address together with such other



documents as may be required as set out in Schedule A. Entries must be received by the Company on or before the Entry Deadline as set out in Schedule A.

- 2.2. Each Event Registration entry by the Registrant may be subject to a standard fee charged by the Registrant's telecommunications service provider as stipulated in Schedule A.
- 2.3. By submitting the Event Registration entry, the Registrant shall be deemed to have read, understood, accepted and agree to be bound by the Terms and Conditions of the Event Registration.
- 2.4. Submission of the Event Registration entry does not guarantee the Registrant the opportunity to participate in the Event Registration or to the ticket giveaway. The Company shall be entitled to reject or refuse participation by the Registrants for reasons, including (without limitation) where the Event Registration entry is not complete or any provisions in the Terms and Conditions is not fulfilled or adhered to by the Registrant.
- 2.5. Event Registration entry must be received by the Company on or before the Registration Deadline as set out in Schedule A. Entries received after the stipulated time will not be accepted and is ineligible for consideration for ticket giveaway.

## 3. ELIGIBILITY

- 3.1. The Registrant Eligibility Criteria are as set out in Schedule A.
- 3.2. Registrants may be required to submit further proof of their eligibility within such timeframe as may be required by the Company failing which the Company shall be entitled to disqualify the Registrant.

## 4. INELIGIBILITY

4.1. Persons who are ineligible to participate in the Event Registration are as set out in Schedule A.

## 5. **DISQUALIFICATION**

- 5.1. The Company reserves the right to disqualify Registrants and/or revoke the ticket giveaway (at any stage of the Event Registration) if:-
  - 5.1.1. The Registrant are ineligible or does not meet any of the Eligibility Criteria; or
  - 5.1.2. The Registrant breaches of the Terms and Conditions or other



rules and regulations of the Event Registration or violated any applicable laws or regulations; or

- 5.1.3. in the Company's sole determination, it believes that the Registrant has attempted to undermine the operation of the Event Registration by fraud, cheating or deception.
- 5.2. In the event of a disqualification after the Ticket has been awarded, the Company reserves the right to demand for the return of the Ticket or reject the ineligible Registrant's entry to the Concert venue.
- 5.3. Whilst the Company will endeavour to conduct necessary verifications on the eligibility of Registrants, failure to disqualify any ineligible Registrants shall not be deemed a breach by the Company.

# 6. WARRANTIES

- 6.1. The Registrant represents and warrants with the Company that -
  - 6.1.1. the Registrant has met all the eligibility criteria and has the right, authority and power to enter into the Event Registration in accordance with Terms and Conditions and shall provide such proof as the Company requires;
  - 6.1.2. all the statements (if any and if so required) made by the Registrant to the Company are true correct accurate and complete.
- 6.2. In consideration of the Company offering to the Registrant the opportunity to participate in an Event Registration and Concert ticket giveaway, the Registrant hereby unconditionally and irrevocably;
  - 6.2.1. agrees that if so required by the Company, the Registrant shall make himself/herself available (without compensation) for the production, recording and publicity of the Event Registration and Concert and ticket giveaway during the such time and production schedule as may be notified by the Company:-
    - (i) interview (which shall be recorded); and/or
    - (ii) taking of still photos, audio and/or visual recording for promotions and publicity use. (collectively "Recording").
  - 6.2.2. agrees and consents that the Company shall have right and absolute discretion to broadcast the Recording and/or use the slogan, names or nicknames on any of its programmes/channels in whole or in part at the Company's discretion. All copyrights subsisting in the Recording shall belong to the Company absolutely.

6.2.3. agrees that where Registrants are required to submit any



photographs, drawings, pictures, slogans, any materials or other creative works, including voice or video recordings (collectively "Intellectual Property") with the Event Registration Entry, the Registrant warrants that all Intellectual Property Rights in such submission does not infringe any third party intellectual property rights.

- 6.2.4. agrees that the Company reserves the right, at its sole and absolute discretion, to use and exploit the Intellectual Property via any means or media and in any manner and anytime that it deems fit without first obtaining any consent nor making any payment whatsoever to the Registrant and/or the Ticket Holders and/or representatives.
- 6.2.5. confirms that the Registrant has read and understood Terms and Conditions of the Event Registration and the Registrant agrees to abide by the said terms and conditions accordingly and agrees to cooperate and to follow all directions given to the Registrant.
- 6.2.6. agrees that all Tickets to be given away in the Event Registration is contingent upon the accuracy of the information provided and disclosures made by the Registrant and the full and complete performance of the Registrants warranties, undertakings and obligations hereunder.
- 6.2.7. agrees that the Registrant shall not by act or omission, directly or indirectly bring the Company or the Sponsor into disrepute.
- 6.2.8. agrees that the Registrant shall not without the prior written consent from the Company publish or disclose any information in connection with the Event Registration or Ticket (including without limitation, to any representatives of media in any form whatsoever).
- 6.2.9. agrees that the Registrant shall not give any product endorsement, any interviews or be involved in any articles or reports in respect of the Event Registration or the Ticket with any third party.
- 6.2.10. agrees that the Registrant's participation in the Event Registration and/or Programme does not entitle the Registrant to wages, salary or any other compensation.



## 7. TICKETS

- 7.1. The Tickets for the Event Registration shall be as set out in Schedule A.
- 7.2. The successful ticket holder names will be notified by the Company by such mode and in such manner as set out in Schedule A.
- 7.3. All Tickets must be collected within the Collection Period and at such Collection Venue as set out in Schedule A. Failure to claim Tickets shall result in the Tickets being forfeited by the Company and the Company, its agents, sponsors and representatives shall have no liability to the Registrants in any respect whatsoever.
- 7.4. All Tickets are strictly not transferable, assignable exchangeable or collectable by the Registrant in any other form or manner other than that specified by the Company. All specific or special terms and conditions that are attached to the Ticket (whether by the Company or its agent or sponsor) must be adhered to by the Registrant.
- 7.5. Tickets must be claimed in person unless the Company prescribes other mode of collection. Where the Company elects to post a Ticket to a Registrant, no responsibility will be accepted by the Company for the safe and effective postal delivery of the Ticket.
- 7.6. In special situations, and subject to the absolute discretion of the Company, a Event Registrant may nominate a designated representative to collect a Ticket. The representative will be required to present written authorisation from the Event Registrant and identification which includes a photograph for both the Event Registrant and his/her representative.
- 7.7. The Registrant is responsible for any and all taxes payable as a result of a Ticket being awarded or received (if applicable).
- 7.8. In the event that the Registrant chooses not to accept or collect a Ticket, the Ticket shall be forfeited and the Ticket which will be dealt with according to the absolute discretion of the Company.
- 7.9. All Tickets are accepted entirely at the risk of the Registrant and are awarded by the Company and/or sponsors without any warranty of any kind express or implied. The Registrant shall execute a deed of release and indemnity in a form prescribed by the Company, if so required, in order to receive the Ticket.



### 8. DECISIONS OF THE COMPANY

- 8.1. The criteria for Registrants shall be as set out in Schedule A.
- 8.2. Notification of Successful Registrants will be sent via the means as set out in Schedule A.
- 8.3. The Company's decisions on all matters relating to the Event Registration (including without limitation, the eligibility of Registrants for ticket giveaway, the Event Registration and/or any resolutions made) shall be final and absolute and binding on the Registrants. No discussion, correspondence, enquiry, appeal or challenge in respect of any decision of the Company will be entertained.
- 8.4. The Registrant shall not dispute nor make any oral or written complaints, public announcements or statements on the same whether during or after the Event Registration Period.

### 9. **PROMOTIONAL ACTIVITES**

- 9.1. The Company and/or its affiliates reserve the right to send application messages or email notification to the Registrants mobile phone numbers or email address containing information and promotional activities regarding any other TVS promotions.
- 9.2. If a Registrant does not wish to receive such application messages or email the Registrant is required to call and inform the Company accordingly.

#### 10. <u>GOVERNING LAW</u>

10.1. The Terms and Conditions of the Event Registration shall be construed, governed and interpreted in accordance with the laws of Malaysia as applicable in Sarawak.

## 11. <u>CONFIDENTIALITY</u>

11.1. The Registrant shall treat all Terms and Conditions and rules and regulations of the Event Registration and all information and knowledge obtained by the Registrant in relation to and/or in connection with the Event Registration and/or Programme and/or derived as a result of his/her participation in the same, including without limitation the Company's business and operational details, the Event Registration mechanics, the criteria for the Event Registration (hereafter collectively



known as "Confidential Information"), as confidential and the Registrant shall, during and after the Event Registration Period, take all reasonable precautions to prevent disclosures of the Confidential Information to unauthorized persons or entities for any reason unless the said Confidential Information is made available to the public by the Company.

### 12. <u>INDEMNITY</u>

- 12.1. The Registrants forever waive, release and discharge the Company, its agencies, sponsors and representatives from and against, any and all liabilities, costs, loss, damages or expenses which the Registrant or any party claiming through the Registrant hereafter may have arising out of acceptance of any Ticket(s) or participation in the Event Registration including (but not limited to) personal injury and damage to property and whether or not direct, consequential or foreseeable.
- 12.2. The Registrant shall indemnify the Company, its affiliates, agent and sponsors from and against all liability, cost, loss or expenses sufferred thereby as a result of the Registrant's breach of the Registrant's warranties and undertakings and any breach of the Terms and Conditions and/or the rules and regulations of the Event Registration.

#### 13. <u>COSTS</u>

13.1. All costs incurred by the Registrant in relation to and/or with respect to the Event Registration including without limitation postal charges or Internet Service Provider (ISP) charges (if applicable), all transport costs, communication charges, accommodation, meal costs and other related costs incurred by the Registrant as a result of and/or pursuant to his/her participation in the Event Registration shall be solely borne by the Registrant. The Company shall not be under any obligation to reimburse the Registrant for any of such costs and expenses incurred thereof.

#### 14. <u>LIMITATION OF LIABILITY</u>

- 14.1. The Registrant acknowledges that his/her participation in the Event Registration shall be at his/her own risks.
- 14.2. The Company, its agents, sponsors, representatives, affiliates and their respective directors, officers and employees, agents and assigns shall not be liable to any Registrant in respect of any failure to obtain a Ticket in the Event Registration, defective Tickets or misuse of Tickets or any other loss, damages, costs, expenses, claims, liabilities, injury, death, accidents suffered by the Registrant during the Event Registration or



arising out of or in connection with the Event Registration, the participation by the Registrant in the Event Registration and/or the Tickets awarded.

- 14.3. The Company will not be responsible or liable for:
  - 14.3.1. any problem, loss or damage of whatsoever nature suffered by the Registrant or any party due to any delay and/or failure in receiving and sending a Event Registration Entry as a result of any network, communication, ISP or system error, interruption and/or failure Company experienced bv the or the Registrant's telecommunication service provider and/or resulting from participation or the downloading of any materials in the Event Registration. In the event of such error, interruption and/or failure, the Company shall not be responsible or liable for any failure encountered by any Registrant to participate in the Event Registration or any failure encountered by the Company in fulfilling its obligations hereunder.
  - 14.3.2. any error (including error in notification of Event Registration Registrants), omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft, destruction, alteration of, or unauthorized access to entries, or entries lost or delayed whether or not arising during operation or transmission as a result of server functions, virus, bugs or other causes outside the Company's control.

#### 15. <u>GENERAL</u>

- 15.1. The Company, its agents, sponsors and representatives shall not be liable to perform any of their obligations in respect of the Event Registration and this Terms and Conditions, rules and regulations in respect of the Event Registration where they are unable to do so as a result of circumstances beyond its control and shall not be liable to compensate the Registrants in any manner whatsoever in such circumstances.
- 15.2. The Registrants shall not be entitled to assign any of the rights or subcontract any of the obligations herein. The Company shall be entitled to assign or sub-license the whole or any part of its rights hereunder to any third party as may be determined by the Company.
- 15.3. All rights and privileges herein granted to the Company irrevocable and not subjected to rescission, restraint or injunction under any and all



circumstances. Under no circumstances shall the Registrants have the right to injunctive relief or to restrain or otherwise interfere with the organization of the Event Registration, the production, distribution, exhibition and/or exploitation of the Event Registration and/or Programme and/or any product based on and/or derived from the Event Registration and/or Programme.

- 15.4. The invalidity, illegality or unenforceability of any terms hereunder shall not affect or impair the continuation in force of the remainder of the Terms and Conditions of the Event Registration.
- 15.5. The main language of the Terms and Conditions shall be the English language. Any translation to any other language than English shall be for convenience only. In the event of any inconsistency between this English language and any other languages, the English language version shall prevail and govern in all respects.
- 15.6. No refunds or exchange of tickets will be made under any circumstances. Ticket holders arriving late to the Concert will only be permitted entry during times as deemed appropriate based on the discretion of the Company.
- 15.7. Smoking at the Concert venue is strictly prohibited except for designated area only.
- 15.8. To be permitted entry to the Concert venue as an audience member, the ticket holder must not dress in an exceedingly exposed or provocative manner or in any manner deemed unacceptable by the Company. Additionally, the ticket holder must comply with typical, heterosexual and gender binary norms for dress codes. The Company reserves the absolute right to refuse ticket holder to venue entry for failing to comply with acceptable dress codes.
- 15.9. The ticket holder must be able to show, for physical wristband ticket collection purposes, the confirmation email sent to the ticket holder and the original Identity Card or Passport registered online during the Event Registration. In the event the confirmation or documents provided are insufficient to verify the identity of the individual and/or purchaser, the Company reserves the absolute right to refuse ticket holder to venue entry. No person is allowed to enter the venue without a physical wristband ticket. The Company will not be responsible for any ticket that is lost, stolen or destroyed.
- 15.10. On ground Concert venue access control procedure and method are



bound by the Terms & Conditions of Event Registration and Free Ticket Giveaway specified here in and any other provision as may be specified from time to time.

- 15.11. In the event of any change of the Identity Card(s) or Passport submitted during the online registration, the current valid Identity Card or Passport must be produced before the Company's representative, agent or any such authorized personnel in order to be registered. The Company reserves the right to request for further confirmation or documents to verify the identity of the ticket holder. In the event the confirmation or documents provided are insufficient to verify the identity of the ticket holder, the Company reserves the absolute right to refuse for venue entry.
- 15.12. Ownership or possession of the ticket does not confer any rights (by implication or otherwise) on the ticket holder to use, alter, copy and/or otherwise deal with any of the symbols, trademarks, logos and/or intellectual property appearing on the ticket.
- 15.13. Information is collected from those registering with the Company's representative, agent or any such authorized personnel in order to facilitate ticket or other services available. The information is collected and used in accordance with our Privacy Policy.
- 15.14. The information collected from those registering with the Company in order for marketing promotion will be processed in accordance with the Privacy Policy. By registering, the Registrant provides his/her consent to the Company in processing their information and permits sponsors, partners and/or authorised parties to contact Registrant to receive marketing materials and communications for future events, promotions and any other marketing and promotional activities.
- 15.15. Purchase or Giveaway from Unauthorised Sources / Refusal of Admission
  - i. The Concert is a free event. Free Ticket Giveaway shall only be made to the public in our designated website at (https://www.tvsarawak.my/kejutan-tvs/) ("Website"), Any Ticket purchased from any other source may be unauthorised copies and purchaser(s) may be refused admittance to the Event.
  - ii. In the event that the Registrant provides false or incorrect data when making the purchase, the ticket holder may be barred from attending the Concert.



- 15.16. The Company reserves the right, without refund of any amount paid, to refuse the admission to, and/or eject any person whose behaviour does not comply with the rules and regulations set forth by the Company's representative, agent or any such authorized personnel and/or the venue.
- 15.17. Wristband tickets are non-transferable and cannot be resold. All Ticket will be rendered as invalid if transferred or resold.
- 15.18. Weather condition

As the Concert is an indoor event, it will not be impacted by rainy weather.

- 15.19. Delay and Postponement
  - i. The Company does not allow any exchange or cancellation of tickets under any circumstances and tickets sold are neither transferrable nor refundable unless otherwise permitted under paragraph below.
  - ii. In the event of postponement, the ticket registered for the original event date may be applicable and valid for the new event date unless otherwise notified.
  - iii. The Company reserves the right to postpone, cancel, interrupt or stop the event due to adverse weather, dangerous situations, or any other causes beyond its reasonable control.
- 15.20. Cancellation
  - i. The Company reserves the right to postpone, cancel, interrupt or stop the event due to adverse weather, dangerous situations, or any other causes beyond its reasonable control.
  - ii. In the event any of the performing group is unable to attend or participate, and beyond the Company's reasonable control, no refund can be claimed under any circumstances.
  - iii. The Company reserves the rights to change or amend any terms and conditions at any time at its sole and absolute discretion without prior notice.
- 15.21. Consent

During the Concert (including entry into the Concert), the ticket holder agrees to submit to any search for any prohibited items including but not



limited to weapons, controlled, dangerous and illegal substances and recording devices.

15.22. Assumption of Risk
